Dear Los Feliz Council leaders,

It's the end of the fiscal year, and we'll be focused on wrapping up the Neighborhood Council elections and reports back to City Council on Neighborhood Council reforms and special budget reports. We will also be preparing for next year's projects, which include building out the Office of Civic Engagement with the focus of conducting Civic Universities and engaging underrepresented communities in Los Angeles. The new Resilient LA Neighborhood Council Plan templates will be released this summer so boards can begin discussions on how to create a resilient community. As you may have heard, General Manager Grayce Liu will be transitioning into her new role as the City Engagement Officer at the Personnel Department. She will remain at the department until a new General Manager is selected and confirmed by City Council. Mayor Eric Garcetti would like feedback from the Neighborhood Councils on what qualities to look for in the new General Manger. Please click [here](#) to provide your input by June 12th.

Citywide Campaigns

The Cannabis Social Equity Program (SEP) is one tool the City of Los Angeles is using to begin to acknowledge and repair the harm caused by the War on Drugs and the disparate enforcement of cannabis prohibition. The goal of the Social Equity Program is, "to promote equitable ownership and employment opportunities in the cannabis industry in order to decrease disparities in life outcomes for marginalized communities, and to address the disproportionate impacts of the War on Drugs in those communities." The Department of Cannabis Regulation is entering into the last phase of our licensing process which is available only to folks in the City of Los Angeles who qualify as SEP applicants. Importantly, all potential applicants must have their social equity status verified by the department before they are able to apply for the next round of licensing which begins on September 3rd. As such, we will be opening up our SEP Eligibility Verification Process from May 28th through July 29th. We have another workshop coming up on Wednesday, June 5th from 6-8pm (info is on the flyer) where folks can learn about the Social Equity Program, the process to get verified as an eligible SEP candidate and how to prepare for the the 3rd Phase of Licensing. Admin

We'd like to thank the Mayor's Budget Team, the Budget and Finance Committee, the Chief Administrative Officer team, and everyone else who supported our requests during the 2019-2020 budget proposal cycle. The Department's existing operations were all funded for another year, and additional funding was provided to continue the work of creating an Office of Civic Engagement that will collaborate with City Agencies, Neighborhood Councils, and stakeholders to outreach, educate, and provide useful tools for improving City services and their delivery to the public. The final budget was approved by City Council on May 23rd and pending final approval by the Mayor, will be adopted by June.

Funding

The Admin Packet Is Ready

The Administrative Packet for Fiscal Year 2019-2020 is now available. The Admin Packet allows your Board to plan and create its annual budget, confirm the Financial Officers serving your Board, and to confirm or let us know of any administrative services, i.e. storage space, website support, for the upcoming Fiscal Year. Please visit our [website](#) to download the Packet. You'll find it in the Documents and Forms section, under Governing Documents. Plan on submitting your Admin Packet by the beginning of the new Fiscal Year, July 1st, in order to gain access to your annual funds when the Fiscal Year starts.

NCs that have not submitted an annual budget and Administrative Packet to the NC Funding Program when the new Fiscal Year begins will be limited to \$333.00/month for Office/Operational expenditures only.

2nd Cardholder

Starting next Fiscal Year, NCs will be able to appoint up to 2 Credit Cardholders, at the board's consideration and approval. Having a 2nd Cardholder will provide NCs with greater access to their annual funds, especially in times when one Cardholder is unavailable due to travel outside the City or other reasons. This should also minimize the need for board member reimbursements. The same requirements and responsibilities will apply to both Cardholders as custodians of the NC credit cards. Once appointed, the 2nd Cardholder will also be registered to access the Funding System portal.

NC Inventory

As DONE recently transferred inventory records of NCs to the Funding Program, we will begin working with your NC so that your inventory record can be updated from the last time your Board reviewed and approved it. Please stay tune for further instructions from our Office on updating your inventory record, which may involve adding any new applicable purchased items or changing the status (i.e. stolen, salvaged, etc.) of previously inventoried items.

Deadlines & Training!

Please keep an eye on the remaining deadlines impacting the Funding Program as we approach the end of the Fiscal Year:

June 1, 2019 - Final date to submit a check payment request.

June 20, 2019 - Final date for any bank card transactions.

In addition to our regular in-person Funding Program and System portal training sessions scheduled at City Hall, we have been doing additional sessions throughout the City to accommodate new appointed or elected Financial Officers. The remaining sessions will be in the West L.A. and South L.A. Areas in June. Again, in addition to our standing sessions in City Hall. All sessions are open to all board members and the general public. Outreach

Five regions for elections remain in this election cycle: West Area, South LA 1, Harbor, South LA 2, and Downtown LA Neighborhood Council. In reviewing our data, we have 1804 registered candidates that applied citywide. Out of the 1804 candidates, 915 candidates are new board members. Outreach efforts are continuing for the upcoming regions. Flyers, mailers, NC 101, and social media campaigns being used to assist with voter turnout. Since many candidates are new to the system, we have made an effort to reach out to help assist with the elections process.

Policy

Civic U emphasizes civic and community engagement and gives Neighborhood Council leaders the tools they need to understand city government and influence policy at City Hall. Since the first Civic U, over 300 Angelenos have completed and graduated the program. The Department of Neighborhood Empowerment/EmpowerLA in collaboration with the Mayor's Office and Cal State LA Pat Brown Institute, invite each Neighborhood Council to select one male and one female to the cohort of Civic U 1.0. Civic U 1.0 will be held on Monday, July 15, 22, and 29 from 6 pm - 9 pm. Space is limited, so please [register](#) as soon as possible!

"We cannot build a better Los Angeles without an engaged population that knows how to navigate city government," said Mayor Garcetti. "That's why the Civic U emphasizes civic literacy: it's not just about your vote at the ballot box, it's about making sure your elected officials are representing your interests."

Instructors will be under the supervision of Dr. Raphael Sonenshein, Executive Director of the Pat Brown Institute (PBI), and author of three books on Los Angeles politics and government. Teaching staff, guest speakers, and group facilitators will be drawn from the Pat Brown Institute (PBI), Cal State LA Faculty, the Mayor's Office, other city offices, the Center for Nonprofit Management, and trained by the Pat Brown Institute.

Board Members with Expired or Missing Mandatory Trainings

To vote on Neighborhood Council funding items, Neighborhood Council board members must have current ethics training and funding training. The Neighborhood Council bylaws may also require these trainings to vote for nonfunding items as well. To serve on a board, Neighborhood Council board members must also have either read and signed a Code of Conduct or have watched the video. To complete these trainings, please click [here](#).

NOTE: in person and online ethics training must be a minimum of 2 hours. If you complete the ethics training online, please ensure that you take 2 hours to complete the training as we will not accept any certificates that show less than 2 hours.

Board Members who have not completed the Funding training:

Funding - Eligibility to Vote on Financial Matters a. To be eligible to vote on any NC Expenditure, Financial Reports, and/or annual budgets, the board member must:

- Be an Elected, Appointed and/or Selected Board Member of the NC
- Be 18 years of age or older
- Have completed the California State Ethics Training Requirement for Local Officials (AB 1234)
- Have completed the online NC Board Member Funding Training and obtain a passing score of 70% on any test associated with the online course.

Board Members with missing or expired Ethics Certificates :

ETHICS - All Board Members are bound by California State Law to take Ethics Training every two years. Take the online course, and send your certificate to Rosters@EmpowerLA.org . Ethics Training is a required for all Board Members
