PRNC Board Meeting

Motion:

Per PRNC Bylaws Article V - Section 8, we hereby move to Censure Becky Leveque who has engaged in conduct that is contrary to rules and regulations applicable to PRNC and impedes the orderly business of Board operations. On her persistent disruptive conduct at meetings, violations, abuses of the Board's bylaws or rules, violations of the Code of Conduct, acting on.

Description:

On July 8, 2020 during PRNC monthly board around 8:20PM while discussing agenda item 11 "Discussion and possible action on the lack of progress on the installation of the approved left-turn-signal at the Intersection of Wilbur & Rinaldi – A. Alnajjar & D. Balen (Att. E)" Becky Leveque became very disruptive and start attacking the authors of this motion in various ways.

Becky Leveques's conduct in regards item 11 as outlined below is contrary to rules and regulations applicable to the Board and impedes the orderly business of Board operations. We feel this is grounds for censure due to her persistent disruptive conduct at meetings as it relates to the Safety Committee Chaired by Asaad Alnajjar, violations of the Code of Conduct by resorting to a series of redhering to obstruct the Safety Committee.

- 1- Becky Leveque, with no cause and no relation to the agenda item 11 started questioning Mr. Alnajjar on his City employment title, department and division which has no bearing on the issue. It is our conclusion here that her intention to possibly blame Mr. Alnajjar personally for the lack of services that should have been delivered by Councilmember John Lee office. Further, Ms. Leveque singled out Mr. Alnajjar on employment history and hence acting in bad faith for unknown reasons.
- 2- Becky Leveque, insinuated and then directly falsely accused Mr. Alnajjar, Mr. Balen and the Safety Committee of making design decisions as it relates to the intersection of Wilbur and Rinaldi without community meetings or board discussions contrary to what the whole motion is all about which is to actually to grant authority by the board to pursue a resolution.

- 3- Becky Leveque, resorted to fog the multiple safety issues revolving around this intersection and introduced a series of questions that was already discussed in a presentation by the contractor to PRNC when Ms. Leveque; as always; was absent and issues where discussed by CD 12 Chief of Staff through a City of LA Planning department hearing without PRNC or community involvement till late stages. PRNC President Issam Najm reminded Ms. Leveque that all her questions, concerns and suggestions has already been discussed in her absence of that meeting and asked to move forward with the motion discussion.
- 4- Ms. Leveque again attempted to blame Mr. Alnajjar and Mr. Balen for decisions that were actually solely made by CD 12 Chiefs of Staff with no PRNC board members involvement, feedback or comments. Blinded by her hatred towards Mr. Alnajjar she didn't realize that her attacks should be directed at CD 12 staff rather than the authors of the motion.
- 5- This intersection involves many contractor's design, procedures and permit issues that was overlooked by CD 12 office and there is no reason for Ms. Leveque to be blaming any PRNC member for this deficiency.

Given all what was presented above and as recorded in the July 8, 2020 meeting video recordings and as documented in many previous meetings, we are forced here to request to censure Becky Leveque effective immediately to save PRNC any further embarrassments of her actions.
